PARTICIPANTS STUDIED AND WERE FORMED BY THE COMPASSION TRADITION ARTICULATED BY THE SCRIPTURES, THE CHURCH'S HISTORICAL WITNESS, THEOLOGICAL INQUIRY, AND CHURCH SOCIAL TEACHING. MANY INDIVIDUALS EXPERIENCED A CONVERSION, INTEGRATING THEIR PERSONAL SPIRITUALITY WITH ACTS OF SERVICE TO THE POOR AND VULNERABLE IN THEIR CHURCH AND IN THE COMMUNITY AT LARGE.
